7. COMMENTS BY THE ADMINISTRATION:

7.1 Deputy City Clerk- Edna Givins- Nothing to report.

7.2 Finance Officer Edna Givins- Sales tax revenue for 1st quarter 2019 is \$60,664,455 (6.34%) increase over 2018 1st quarter. The shut off report: our scheduled disconnect for nonpayment for March 12, began with 34 customers on the list for disconnection and as of 4:45 pm, we still had 12 customers. The total amount due for these customers was \$9,494.28, the amount owed for the last 12 is \$4,528. Of the 12 we have confirmed that 2 of them have left without finalizing their account for a total of \$1,131.23 and the deposit for these accounts is \$600.

7.3 Chief Curenton- Absent

7.4 Fire Chief Mike Shempert- The new tanker is supposed to be done by the end of March, however, the chase is still not complete. Fire Department did a great job on the apartment fire last week. Contained the fire and only 4 units were lost, with no loss of life.

7.5 Public Works Director Steve Long- Winter weather on the 3rd went well. Crews kept the roads clear with no reported issues. Ridge creek area well went down, it was reset and brought back online. Public Works replaced pipes in Oak Point Apartments, there are more pipes on order. Crews will continue working to complete this project. Natural gas lead was reported in Freedom park (cold fuse) was replaced quickly. Superior water tower is still being tested to find what is causing the issues.

7.6 IT Manager, Don Coplin- Software from 2 weeks ago was ran on a sample computer and found 8 new malwares and 1 new virus that was not found by previous software.

7.7 Transfer Station Manager Jay Whittaker- The tonnage for February was 390.5 tons. The last trailers have been returned after repairs. Weather causes issues getting trucks to the landfill. However, they were taken the next day with no issues.

7.8 City Attorney- Tyce Smith- There has been a lot of movement on the 911 TIF case, there should be a judgment in the next few weeks. The Fincher case is almost complete.

7.9 Interim City Administrator- Anita Ivey- Ground breaking on new the new jail. Citizens send thank you letters for snow removal teams. Getting signs up for the VA above their door. Moving forward on lighting. WWTF evaluations are complete and went well. Interview are scheduled for tomorrow. On April 13, there will be an Easter egg hunt put on by the City in the park.

8. COMMENTS BY THE MAYOR: The Mayor would like Anita to contact the victims of the apartment fire to ensure they are taken care of. MO Gas is waiting for documents to be submitted, there looking at a 10-12% pipeline increase.

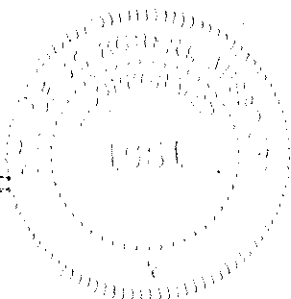
